BE IT FURTHER RESOLVED that the Board of County Commissioners hereby and herewith makes the following appointments of representatives for 2011:

Commissioner Donald Rosier as Jefferson County representative to the Denver Regional Council of Governments (DRCOG), and Commissioner Kevin McCasky as alternate:

Commissioner Faye Griffin to the Urban Drainage and Flood Control District Board;

Commissioner Faye Griffin to the E-911 Board, provided, however, in case of Commissioner Griffin's unavailability, Tim McSherry will be Jefferson County's alternate representative to the E-911 Board;

Commissioner Donald Rosier to the Boundary Control Commission, Commissioner Faye Griffin as the first alternate and Commissioner Kevin McCasky as the second alternate;

Commissioner Donald Rosier to the Jefferson Economic Council, and Commissioner Faye Griffin and Commissioner Kevin McCasky as alternates;

Commissioner Kevin McCasky to the Jefferson Center for Mental Health Board, and Lynn Johnson as alternate;
