**Procedure:** Airport Rules and Regulations

**Purpose:** To establish policies governing the Rocky Mountain Metropolitan Airport (Airport) to protect the public health, safety, interest, and general welfare on the Airport and to restrict (or prevent) any activity or action which would interfere with the safe, orderly, and efficient use of the Airport by its Operators, Lessees, consumers, and users.

Policy: Airport Rules and Regulations

## A. Use of Airport

- Any permission granted directly or indirectly, expressly or by implication, to any Entity to
  enter upon or use the Airport (including Aircraft Operators; Vehicle Operators; Aircraft
  crewmembers and passengers; spectators and sightseers; occupants of private and
  commercial Vehicles; officers, employees, and customers of Operators and Lessees;
  Entities doing business with the County and/or Airport Director, its contractors,
  subcontractors, and licensees; and all other Entities whatsoever) is conditioned upon:
  - a. Assumption of responsibility by every Entity exercising or taking advantage of such permission.
  - b. Full and complete compliance with the Rules and Regulations, all Primary Guiding Documents, and applicable Regulatory Measures.
- Each such Entity shall at all times release, hold harmless, and indemnify the County, Airport, and the Board of County Commissioners (BCC) (individually and collectively), representatives, officers, officials, employees, agents, and volunteers from any and all responsibility, liability, loss or damage that may result to any Entity, be caused by or on their behalf and/or incident to the manner in which the Airport is operated, constructed, maintained, served, or used.

## 3. Responsible Party

Any person accessing or using the Airport shall be responsible for their actions and all actions of any person to whom they provide or facilitate access, whether directly or indirectly.

## 4. Civil Rights

No person shall, in the use of the Airport, discriminate or permit discrimination against any other person or group of persons on the basis of race, color, religion, sex, age, disability, or national origin.

## B. Airport Director Authority

- 1. The Airport Director shall develop Airport Rules and Regulations.
- 2. The Airport Director has the authority to take such action as may be necessary to enforce the Airport Rules and Regulations, including but not limited to setting fines.
- 3. In any contingencies not specifically covered by the Airport Rules and Regulations, the Airport Director is authorized to make such rules and render such decisions as to him/her may seem proper.
