Purpose: To assure public access to Jefferson County buildings and facilities and to restrict certain parking spaces at County buildings and facilities for designated use only.

Policy: Parking at Jefferson County Buildings and Facilities

A. Intent

This parking control regulation is established pursuant to the authority contained in C.R.S. §§ 18-9-117 and 30-11-107(1)(a) in order to assure public access to Jefferson County Buildings and Facilities and to restrict certain parking spaces at County Buildings and Facilities for designated use only.

- B. Definitions: As used in this regulation, the following words shall have the following meaning.
 - "Jefferson County Buildings and Facilities" means all buildings owned and/or used by Jefferson County, its elected officials, divisions, and employees, including, but not limited to, the Jefferson County Administration and Courts Facility, the Jefferson County Detention Facility, the Jefferson County Sheriff's Office, the Jefferson County District Attorney's Office, Jefferson County Open Space, the Laramie Building, the Dakota Building, all Road and Bridge Shops, all Sheriff precincts, all Motor Vehicle Offices, and all Public Health Offices.
 - 2. "Licensed Towing Carrier" means a towing carrier as defined in C.R.S. § 40-10.1-101(20), who has an active and valid permit pursuant to C.R.S. § 40-10.1-401.
 - 3. "Parking Areas" means those areas designed and/or used for parking vehicles.
 - 4. "Vehicle" means a device that is capable of moving itself, or of being moved, from place to place upon wheels or endless tracks, including but not limited to Motor Vehicles, Major Motor Vehicles, Major Recreational Vehicles, and Trailers.

C. Reserved Parking Spaces

- 1. The County Administrator may reserve and post specific parking spaces and/or designate or restrict access to Parking Areas for employee use only or visitor use only.
- 2. The County Administrator may work with any adjacent property owner to develop a parking management plan if parking for those services/businesses interferes with access to Jefferson County Buildings and Facilities.

D. Parking Violations

- 1. Any Vehicle which is parked at a Jefferson County Building or Facility that interferes with public access to the buildings or facilities may be removed from the property and impounded. Removal of such vehicles shall be done by a Licensed Towing Carrier at the request of the County. Payment of all storage and towing charges of the Licensed Towing Carrier shall be the sole responsibility of the owner or operator of the towed vehicle and shall be paid by the owner or operator directly to the towing carrier. The location of any vehicle towed pursuant to this regulation may be obtained from the Jefferson County Sheriff's Office, 200 Jefferson County Parkway, Golden, Colorado 80419, (303) 277-0211.
- 2. Any Vehicle which is parked at a Jefferson County Building or Facility in a parking space designated for a specific individual or group, when such vehicle is not owned or used by the designated individual or member of the designated group, may be removed from the property and impounded. Removal of such vehicles shall be done by a Licensed Towing Carrier at the request of the County. Payment of all storage and towing charges of the Licensed Towing Carrier shall be the sole responsibility of the owner or operator of the towed vehicle and shall be paid by the owner or operator directly to the towing carrier. The location of any vehicle towed pursuant to this regulation may be obtained from the Jefferson County Sheriff's Office, 200 Jefferson County Parkway, Golden, Colorado 80419, (303) 277-0211.

E. Severability

Should any sections, clause, sentence or part of this regulation be adjudged by any court of competent jurisdiction to be unconstitutional or invalid, the same shall not affect, impair or invalidate the regulation as a whole or any part thereof, other than the part so declared to be invalid.
