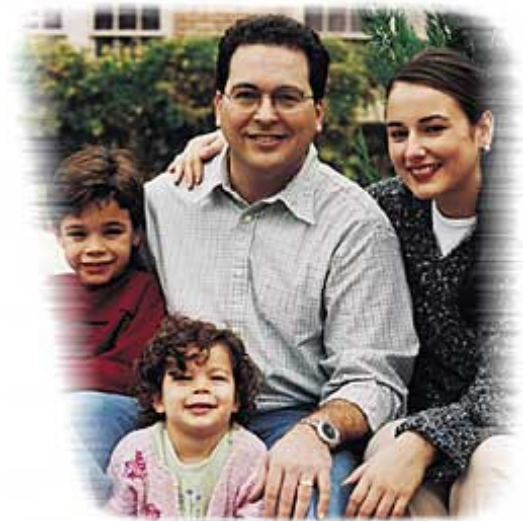

About our organization



FBH is a Behavioral Health Organization (BHO) that specializes in the management of mental health benefits for persons enrolled in the Colorado Medicaid program and living in Boulder, Broomfield, Clear Creek, Gilpin or Jefferson Counties. As

FBH works in partnership with two not-for-profit providers of mental health services.

a BHO, FBH also complies with both Federal and State regulations governing the operation of managed care

health plans financed with Federal and State health care funds.

FBH is owned by two not-for-profit providers of mental health services, The Mental Health Center Serving Boulder and Broomfield Counties (MHCBBC) and Jefferson Center for Mental Health (JCMH). Both Centers are considered leaders in their field.

FBH is operated by a professionally trained staff with diverse specializations. These include the areas of health care administration, provider credentialing and network management, quality assurance and performance improvement, utilization management, consumer rights, consumer advocacy and consumer empowerment.



FBH's professional staff work to improve the quality of life and foster the mental health of Medicaid members and their families.

Access to Services: The Provider Network

The two Network Mental Health Centers (JCMH and MHCBBC) generally serve as the frontline access point for the majority of individuals seeking Medicaid funded mental health services. All of our providers work closely with FBH for quality and service excellence.

The Provider Network also includes a number of highly specialized individuals and organizational providers representing diverse areas of specialization and levels of care. Collectively, the Provider Network serves to ensure that the members of FBH's health plan have access to the full range of mental health services to support their treatment and recovery.
