RV Site Information, Guidelines, and Rules

Information: 40 sites total. All sites include electric and water hookup. There is a central RV Sanitary Dump Station on site. Flush restroom facility and showers are conveniently located in the RV area. Tent camping is allowed. Camp Hosts on-site. Free WiFi. Updated playground area and large picnic pavilion available for use if not previously reserved.

Rates: Sites 1-12 (Reservation basis) back-in, paved, 50 amp, water

Daily - \$30.00
Weekly - \$180.00 (payment due up front)
Monthly - \$720.00 (payment due up front)

Sites 13-18 (Reservation basis) parallel, paved, 30 amp, water

Daily - \$25.00
Weekly - \$150.00 (payment due up front)
Monthly - \$615.00 (payment due up front)

Sites 19-40 (Call ahead for availability) pull through, gravel, 30 amp, water

Daily - \$20.00 (No weekly or monthly rates)

After hours drive-ins will be assigned a site as available with no guarantee of more than one night stay.

Check-in time: 12:00 pm

Check-out time: 11:00 am

RV Sanitary Dump Station available on-site, no additional fee for paid RV site rentals, all other RV sanitary dump requests will be charged a \$10.00 dump fee.

Payment and Cancellation: Credit Card required to reserve an RV site, final payment can be credit card, check, or cash. Cancellations up until 48 hours prior to reservation are allowed at no charge, cancellations within the 48 hour period prior to reservation date will incur a one (1) day site rental charge to credit card # provided at time of reservation. *No refunds will be allowed for early departure on weekly or monthly reservations.* (Make checks out to - Jefferson County Treasurer)

Guidelines:

- Payment must be remitted to the Fairgrounds office prior to any utility services being made available.
- Groups renting other Fairgrounds facilities have priority use of the RV sites.
- Site includes 1 RV and 1 companion vehicle, (if companion vehicle(s) does not fit within designated site, then it must be parked in the overflow lot).
- Site capacity includes 1 RV and 1 tent or 2 tents. (Inquire about tent sites).
- Sites will not be rented to minors, (under 18).
- Extensions must be requested and paid for in advance, depending upon availability.
- Emergencies: Call 911, all other after hour needs, (5:00pm - 10:00 pm), contact on-site Camp Host or Fairgrounds staff at (720) 490-5737

- RV Site Rules on back -

Rules:

- **Alcoholic Beverages** – No alcoholic beverages are allowed in campground or on rest of Fairgrounds without a permit.
- **Children** – Children must be supervised by a parent/guardian at all times.
- **Pets** – pets must be on a leash under physical control of owner, kenneled, or in camping unit at all times. Pets are not allowed in the restroom/shower building, near the playground structure or in any other building on the Fairgrounds. Owner is responsible for immediate cleanup and proper disposal of pet waste. (Off leash use allowed only through organized events with permit granted from the Jefferson County Animal Control Department).
- **Quiet Hours** – quiet hours are from 10:00 pm to 8:00 am. Please respect others.
- **Campfires** – fires are allowed only in developed RV sites, in contained portable units, ie; hibachi grill, kettle grill, propane stoves. Charcoal or propane only! There are no provided fire rings! FIRES MAY BE PROHIBITED DEPENDING UPON WEATHER CONDITIONS!
- **Firearms** – brandishing and/or discharging of any type of firearms are not allowed anywhere on the Fairgrounds property.
- **Remote Controlled Vehicles** – the use of any type of remote controlled vehicles are not allowed on Fairgrounds property; includes cars, trucks, planes, etc.
- **Golfing** – hitting of golf balls is not allowed on Fairgrounds property.
- **Waste Disposal** – discharge of grey or black water is strictly prohibited into the environment. (RV Sanitary Dump Station is located on west end of RV area)
- **Washing of RV's** – washing of RV's or any other type of vehicle is not allowed on Fairgrounds property.
- **Aesthetics/Appearance** – RV and immediate area to be kept clean and orderly, ie; no conversion school buses allowed, no clothes lines, no car parts laying around, no general mechanical/maintenance work allowed, (emergency repairs acceptable). All living units, ie; truck mounted campers, camper shells, etc, to remain mounted on trucks at all times. (Fairgrounds Director has final say on vehicle appropriateness)
- **Jack stands/levelers** – must have flat bases or supports between jacks and pavement.
- **Garbage** – all garbage is to be placed in nearest refuse container or dumpster. Only normal campground generated garbage allowed; no broken furniture, grills, rugs, etc...these items are to be taken with you.
- **Fireworks** – fireworks of any kind are not allowed on the Fairgrounds property.
- **Camper's Responsibility** – it is the responsibility of each camper to be aware of and obey all other posted, web site, and/or written Fairgrounds Reservation and Use Policies. Disregard for any stated Guideline or Rule may make you subject to immediate eviction from the Fairgrounds property. Please use common courtesy at all times while on the Fairgrounds property.
