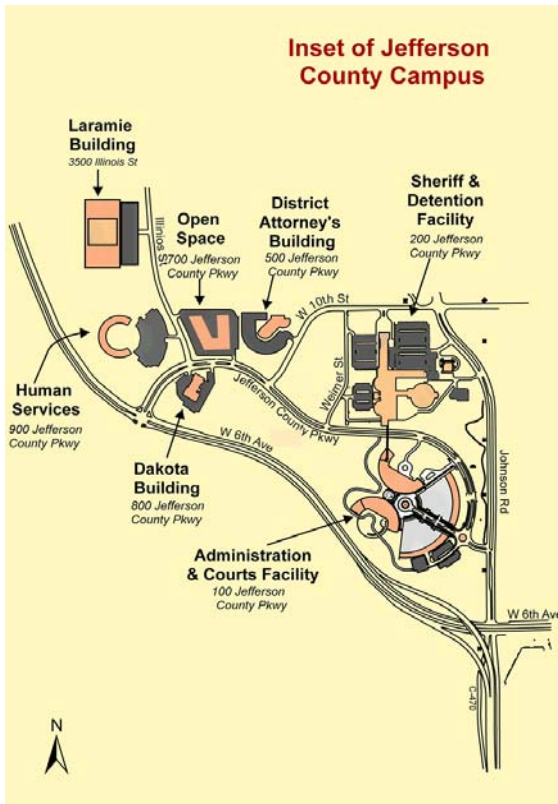

Certified Pool-Spa Operator (CPO) Course

The Certified Pool-Spa Operator Course is designed to prepare individuals in the basic knowledge, techniques, and skills of pool-spa operations. At the conclusion of this class, individuals will:

- Understand the role of the CPO in pool operations and management.
- Minimize physical and biological hazards associated with pools-spas.
- Understand the need for proper documentation as it relates to pool-spa operation and liability risks.
- Develop a network of resource materials and personal contacts.
- Become familiar with local and state bathing codes.
- Perform pool calculations relating to water chemistry balance

Exam and Certification

Participants may use their *Pool-Spa Operators Handbook* and any materials or references given to them during the course. Participants who successfully complete the CPO training and pass the National Certification Examination with a grade of 75% or higher, will become certified.
