MISCELLANEOUS PERMIT APPLICATION

1. This form is only an application until validated by Jefferson County staff.
2. **Fees are on-line at our web site** or call 303-271-8700. Make checks payable to Jefferson County Treasurer.
3. All spaces below must be filled in before turning in application to Jefferson County staff.

Structures

1. All structure permit applications must be accompanied by a **site plan drawn to scale** showing where the structure is to be located in relation to other structures and **property lines**.
2. Construction plans showing height (above grade and of structure).

3. For mini-structures: These types of structures are defined as any single-story detached accessory structure up to **200 square feet**, excluding garages or structures housing automobiles, that is used as a storage shed, chicken coop and run, playhouse or similar use. No more than one mini-structure per residential lot shall be used for storage purposes.
4. For chicken coops and runs, a detailed description explaining the methods used to make the structure predator resistant.

Home Occupations

1. All home occupation permit applications must be accompanied by a **floor plan of the home** showing where the business is to be located.
2. A **detailed letter** stating what you propose to do (what business will you be operating).
