THE UNDERSIGNED AGREES:

- 1. To take every precaution to protect the roadway and the traffic from damage or injury, using pilot cars or flagmen to warn the traveling public on blind curves, both vertical and horizontal.
- 2. To make this traffic movement only between 9:00 a.m. and 4:00 p.m. Monday through Friday, and to remove the traffic load from the roadway except between those hours. Traffic movement shall not be made on holidays.
- 3. To be financially responsible and to make prompt payments for any damage caused by the transportation of this load over public highways and roads.
- 4. That the operator(s) of the vehicle(s) is duly licensed according to statute.
- 5. To operate the vehicle at all times in accordance with any and all provisions of law, except as exempted herein with regard to motor vehicles and the operation thereof.
- 6. Except where the undersigned applicant has requested and is granted permission to exceed weight limits, the applicant represents that this load does not exceed statutory maximums. Where the applicant requests permission to exceed weight limits, the applicant represents that the load cannot be loaded to conform to statutory weight limits.
- 7. This permit is issued with the understanding that no liability is assumed by Jefferson County by reason of its issuance in regard to condition of roads or capacity of culverts and bridges, and the applicant is charged to make necessary examination and inspection as to the adequacy of road or bridges to care for the traffic movement. In case of emergency, the field officials of the County have authority to suspend this permit until emergency conditions have remedial or abated.
- 8. The operator(s) of the vehicles(s) must notify the Jefferson County Sheriff's Office Dispatch at 303-271-0211 at least 24 hours prior to movement. This permit is valid only on those roadways in unincorporated Jefferson County under their jurisdiction.
